Must be 13–18 yrs. old on event date; 13–14 boys & girls may play 9 holes determined by host; all other divisions will play 18 holes

Awards will be given to the three best scores in each age division for both girls and boys.

First place tie will be decided by a sudden death playoff beginning at Hole #1. All other ties will be decided by scorecard playoff.

Note: The top five individuals in each division of both boys and girls from the five tournament sites will be invited to the **State Tournament of Champions at Pontiac Elks Lodge Golf Course on Monday, August 1st, 2011.**
